#### Preparedness and advance preparation

The Pilgrims Affairs Office assigns a coordinator for constant communication throughout the planning period for operations



The number of pilgrims wishing to use the Holy Sites train who are not included in the Holy Sites train for transportation to the Jamarat facility on the Days of Tashreeq is determined according to the designated locations in the Holy Sites and Mecca. The number of pilgrims wishing to use the Haramain train to travel between cities (Mecca - Medina, Medina - Makkah Al-Mukarramah) is determined, with confirmation of their presence on the Hajj electronic route for reservation according to the specified time periods. The Pilgrimage Affairs Office cooperates in nominating, appointing and training assistant group leaders

according to Instructions by selecting pilgrims with the ability to positively influence pilgrims, their mission is to raise awareness

Informing pilgrims of developments and ensuring their regularity and adherence to instructions inside the holy sites. Emphasizing the distribution of the number of pilgrims from the pilgrim's country according to the typical structure of the executive unit: - • The executive unit (the means of movement to serve a certain number of pilgrims (47 pilgrims)). • The regiment is a number (four) of the executive units combined, including (188 pilgrims), a regiment commander, and (Four) guides and an assistant regiment leader from the Pilgrims Affairs Office.





• The movement group is considered to be five regiments with (twenty) executive units and consists of:

Hajj, as well as adhering to the timetables specified for performing the rituals, and that if these instructions are violated, it is considered a violation of



#### Operational requirements for the system of transporting pilgrims between cities and the holy sites:

- Adherence to the instructions for transporting pilgrims, which limit movement between (Makkah, Medina, and Jeddah) to Wafqam company buses, as registered in the service packages of the unified electronic system for pilgrims abroace
- Inform all pilgrims of the obligation to load each pilgrim's personal luggage on the bus in which he will be transported and not to load

• Adherence to the transportation regulations specified according to the places of residence of pilgrims in the Holy Sites

All hospitals in charge of the program for transporting pilgrims at train stations are stressed that they must commit to using the tickets issued by the train operating company

and to stress to pilgrims not to sell them to other nationalities.




