CAREER OPPRTUNITIES AS MEDICAL OFFICERS AND WOMEN MEDICAL OFFICERS IN DHQs AND THQs

Health & Population Department, Government of the Punjab, published advertisement in **daily leading newspapers “Jang, Duniya, Express, Nawai-Waqat, Nai Baat, Express Tribune”** dated; 12-03-2026 vide SPL; 243 **inviting applications from qualified individuals for District Headquarters Hospitals (DHQs) & Tehsil Headquarter Hospitals (THQ) till 24th March, 2026.** A large number of applicants have applied for the posts of Medical Officers and Women Medical Officers. As per terms and conditions of advertisement bearing SPL-243, the Department has decided to short-list the candidates through National Testing Services of Pakistan. The terms and conditions are given below:-

General Terms and Conditions: -

1. The candidates who have applied for the post of Medical Officer/Women Medical Officer on the portal of the Department <https://hspp.pshealthpunjab.gov.pk/> and having **Valid PMDC** are eligible to appear in NTS test.
2. No TA/DA will be admissible to the candidates for test.
3. The Department reserves the right to reject any or all applications, or cancel the whole recruitment process at any stage without assigning any reasons.
4. Final Terms & Conditions of appointment shall be settled at the actual date of appointment.
5. Decisions of Department on all matters concerning recruitment, including eligibility/ short listing/ selection criteria shall be the final.

Procedure for submission of Test Fee: -

6. Candidates shall access the National Testing Service (NTS) website (www.nts.org.pk) using the passcode sent via email and SMS provided during submission of the online application within the due date.
7. Candidates shall upload their photograph and select the test city. Afterwards, their 1Link challan will be available for download.
8. The test fee shall be paid through 1Link 1Bill participating banks, ATMs, internet banking, mobile banking, Easypaisa, JazzCash, or TCS Express Counters using the 20-digit invoice number generated on the fee slip. Only one 1Bill invoice payment will be accepted.
9. The last date for fee payment will be **15th April, 2026.**
10. The test date will be communicated to eligible/shortlisted candidates by the NTS.
11. Candidates shall bring roll number slips and **valid PMDC** at the time of written NTS Test.
12. Candidates achieving 50% marks in the NTS will qualify.
13. In case of a large number of qualifying candidates, the Appointing Authority reserves the right to determine an appropriate threshold or merit ratio.
